## PRODUCER LICENSING BULLETIN NO. 2019-01

**TO: Licensed Oklahoma Agents**

**RE: UVED Re-Verification Request**

**FROM: Oklahoma Insurance Department**

**DATE: May 1, 2019**

On January 1, 2018, in accordance to Senate Bill 115 signed by the Governor on April 24, 2017, the Department of Public Safety (DPS) transferred the Oklahoma Compulsory Insurance Verification System (OCIVS) to the Oklahoma Insurance Department (OID). The OID implemented the new Oklahoma Insurance Verification System (OKIVS) on November 1, 2018. The new system has the ability to verify insurance using real-time connections with the insurance companies. The District Attorney's Council (DAC)'s Uninsured Vehicle Enforcement Diversion Program (UVED) utilizes OKIVS to identify potentially uninsured vehicles. Any uninsured vehicle identified by UVED to be operating in violation of [Title 47, Section 7-606](#) of the Oklahoma Statute will be issued a UVED Notice to Respond.

### **Re-Verification**

Should a policyholder receive a Notice to Respond from the Oklahoma Uninsured Vehicle Enforcement Diversion Program (UVED) and the notice is in error because the vehicle in question was insured on the date of the photograph, they may request a re-verification of their insurance status for the date specified on the notice.

As Agents, you are able to electronically verify the insurance information using the Oklahoma Insurance Verification System at <https://www.okivs.com>.

To register for the OKIVS Re-Verification, please click on the following link: <https://www.okivs.com/Registration/VerifyAgent.aspx>. You will need to provide your Producer License Number (assigned by the Oklahoma Insurance Department) and your Date of Birth to verify your license status.

Once verified, you will complete the one-time setup of your online OKIVS re-verification account. In the future, you will use these credentials for the re-verification of all policy holders.
